The following fire safety measures should be provided in the building as listed below.

III. Group C - Institutional Building Conditions

7.C-2 Custodial Institutions & C-3 Panel And Mental Institutions. (Less Than 10 M In Height Upto 300 Persons)

1. The Fire extinguishers should be provided at all floors in accordance with the IS 2190: 2010 requirements.
2. Hose reel assembly should be provided on all floors.
3. Fire service inlets fitted with NRV at ground level should be provided
4. 5000 litres capacity water tank with 450 lpm pump should be provided at the terrace.
5. If the basement is available and exceeds 200 square meters, an automatic sprinkler system should be installed in the basement. In addition with existing water tank 5000 litres capacity water tank with 450 lpm pump should be provided at the terrace.
6. Manually operated Fire Alarm call points (MCP) should be provided on all floors.
7. Staircases should have a width of 2 meters.
8. Display safety signs throughout the building.
9. Side set back area should be provided as per TNCDB rule 2019.
